Subject: Arts Budget Cuts: CAC, \$10m; CAL-OSBA Equitable Payroll Fund \$12.5m OPPOSE

The organizations listed below strongly oppose provisions in the May Revise of the 2024-25 California budget, which dramatically slashes funding to the California Arts Council (CAC) and entirely eliminates funding to launch the Performing Arts Equitable Payroll Fund (SB 1116, Portantino, 2022). We understand that the state is facing challenging budget deficits and needs to adjust spending, but funding for arts-related programs in California has not grown at the same rate as many other areas of the state budget and shouldn't face disproportionate treatment. In fact, ongoing general fund support for the CAC is still below the 2000-2001 funding level while the state's general fund expenditures have more than doubled over the same time period. We respectfully urge you to reject these cuts.

The May Revise proposes two cuts that will unquestionably decimate small local arts organizations. First, the proposed \$10 million cut to the CAC for Local Assistance Funding represents a 38% reduction to the \$26 million in ongoing general fund support. This proposal would reduce funding for small local arts organizations in every county to a level of general fund support first realized in the 1989-1990 budget year without even controlling for inflation. This is in addition to the May revision's 7.95% reduction to nearly all state agencies. Second, the May Revise completely eliminates \$12.5 million intended for the Equitable Payroll Fund and erases five years of building a bipartisan legislative solution to address the deleterious impacts of the pandemic along with increased payroll and operating costs on California's nonprofit performing arts organizations. In total, these two cuts represent a 58.4% reduction of state arts funding intended to reach and serve communities across all of California.

For too long, California's artists, tradition bearers, cultural organizations and creative businesses have carried the weight of the state's preeminence as a cultural producer and creative economy on their

shoulders, with only minimum sustained public investment. The Federal Bureau of Economic Analysis finds that arts and culture industries generate over 8% of California's economy, support 847,688 jobs and contribute 7.3% of state tax revenue.¹ The more localized Otis Report on California establishes that creative talent is one of driving forces of the sector and that there is a "a deep interplay between amateur, nonprofit, and commercial participants in the creative economy."² In the rural City of Watsonville, the arts and culture sector generates over \$8.8 million in total economic impact, employs 175 creative workers and brings in close to \$500,000 in local tax revenue. Silicon Valley hosts a \$385 million creative industry, employing close to 6,000 creative workers and bringing in over \$7.7 million in local tax revenue.³ The ability of local communities to leverage state public funding is vital to sustaining our sector and uplifting the California economy as a whole.

We urge the Legislature to recognize the drastic nature of these cuts and the destabilizing threats they pose to the livelihoods of the creative workforce and to the promise of core California values. In particular, it is critical to acknowledge that these cuts will hurt the most vulnerable of arts organizations and arts workers including those located in rural communities and communities of color.

Consider the following:

## SHOULD CALIFORNIA RANK 45TH FOR FUNDING OUR STATE ARTS AGENCY? - CAC

funding is lower than it was two decades ago. Funding for the CAC also grew very slowly after the budget challenges of the 2000's, with general fund support at the minimum necessary (approximately \$1million) to obtain federal matching funds for over a decade. Since 2018-19, general fund support has plateaued at \$26 million – just .67 cents per California resident, ranking the state 36th in the nation in per capita arts spending. In contrast, Florida spends almost \$2.00 per resident. The \$10 million cut to the CAC budget would position California at 45th in the nation in local arts assistance funding, just above Kentucky, Kansas and Georgia.<sup>4</sup>

ARTS FUNDING DIRECTLY SUPPORTS JOBS - Cutting \$12.5 million in funding for the implementation of SB 1116 will directly impact job retention and creation in communities across California. That legislation is designed to support the operations of small nonprofit community performing arts organizations, which have faced unique operational challenges along with early and enduring closures and capacity restrictions related to COVID-19. This legislation had bipartisan support and was co-sponsored by labor and management because of the impact on jobs, community, and culture. Similarly, grants from the CAC go directly to creating opportunities for artists, performers, and the organizations that support them.

ARTS PUBLIC FUNDING IS EQUITABLY DISTRIBUTED - Public funding is critical to ensuring equitable access to arts and culture experiences and to opportunities to develop and sustain creative careers. Lack of public investment perpetuates an overreliance on philanthropy which is concentrated in urban and affluent areas. CAC grants reach all 58 counties and are more equitably distributed to underserved groups and regions than private funding. Similarly, the Equitable Payroll Fund will serve small live arts nonprofits in every county across the State, enabling them to grow and sustain jobs for the most vulnerable creative workers.

ARTS GENERATE DOWNSTREAM BENEFITS - According to the National Endowment for the Arts, every \$1 in public arts funding leverages an additional \$9 in local and private investment.<sup>6</sup> And a 2023 report found that for every 100 Performing Arts jobs in 2021, an additional 156 jobs were supported in other sectors.<sup>5</sup> When arts funding is pulled, other businesses will suffer including restaurants, hotels, retail and the overall economic health of downtown communities.

ACCESS TO ARTS, CULTURE AND CREATIVE EXPRESSION IS A CORE SERVICE that delivers a variety of positive societal benefits. From poetry workshops for veterans experiencing PTSD, to mariachi bands bringing warmth and dignity to food distribution lines, to neighborhood mentoring programs for youth to develop creative careers, to performing arts groups providing critical jobs and tourism attractions, to public art and cultural programs serving as the go-to asset for local governments revitalizing neighborhoods, California's arts community is providing goods and services that are essential to the state's wellbeing, community health and economic success.

While we understand that every sector and agency must play their part to balance the budget, the proposed cuts place a disproportionate burden on the California arts workers and nonprofits that, unlike other areas of state government, have not grown substantially during the good budget years. The California Arts Council is already functioning at a cut-level and the performing arts community is facing unprecedented challenges. We believe these modest investments deliver outsized impacts (cultural enrichment, mental health benefits, economic impact) for the state and must be protected.

We urge you to reject the proposed 58% cut to small and nonprofit community arts organizations across California.




